



# Bullying and Prevention Policy

**Purpose**

Grovedale West Primary School is committed to providing a safe and respectful learning environment where bullying will not be tolerated. Grovedale West Primary School has zero tolerance to racism.

The purpose of this policy is to:

- explain the definition of bullying so that there is shared understanding amongst all members of the Grovedale West Primary School community
- make clear that no form of bullying at Grovedale West Primary School will be tolerated
- outline the strategies and programs in place at Grovedale West Primary School to build a positive school culture and prevent bullying behaviour
- ask that everyone in our school community be alert to signs and evidence of bullying behaviour, and understand the importance of reporting bullying behaviour to school staff
- ensure that all reported incidents of bullying are appropriately investigated and addressed
- ensure that support is provided to students who may be affected by bullying behaviour (including targets, bystanders, witnesses, and students engaging in bullying behaviour)
- seek parental and peer group support in addressing and preventing bullying behaviour at Grovedale West Primary School

When responding to bullying behaviour, Grovedale West Primary School aims to:

- be proportionate, consistent, and responsive
- find a constructive solution for everyone
- stop the bullying from happening again
- restore the relationships between the students involved.

Grovedale West Primary School acknowledges that school staff owe a duty of care to students to take reasonable steps to reduce the risk of reasonably foreseeable harm, which can include harm that may be caused by bullying behaviour.

**Scope**

This policy addresses how Grovedale West Primary School aims to prevent, address and respond to student bullying behaviour. Grovedale West Primary School recognises that there are many other types of inappropriate student behaviours that do not meet the definition of bullying which are also unacceptable at our school. These other inappropriate behaviours will be managed in accordance with our Student Code of Conduct and Student Wellbeing and Engagement Policy and Inclusion and Diversity policy.

This policy applies to all school activities, including camps and excursions. It also applies to bullying behaviour between students that occurs outside of school hours, where the behaviour impacts on student wellbeing and safety at school.

Policy Definitions

**Bullying**

In 2018 the Education Council of the Council of Australian Governments endorsed the following definition of bullying for use by all Australian schools:

*Bullying is an ongoing and deliberate misuse of power in relationships through repeated verbal, physical and/or social behaviour that intends to cause physical, social and/or psychological harm. It can involve an individual or a group misusing their power, or perceived power, over one or more persons who feel unable to stop it from happening.*

*Bullying can happen in person or online, via various digital platforms and devices and it can be obvious (overt) or hidden (covert). Bullying behaviour is repeated, or has the potential to be repeated, over time (for example, through sharing of digital records)*

*Bullying of any form or for any reason can have immediate, medium and long-term effects on those involved, including bystanders. Single incidents and conflict or fights between equals, whether in person or online, are not defined as bullying.*

Bullying has three main features:

- It involves a misuse of power in a relationship
- It is ongoing and repeated, and
- It involves behaviours that can cause harm.

There are four main types of bullying behaviour:

- **Physical** – examples include hitting, pushing, shoving or intimidating or otherwise physically hurting another person, damaging or stealing their belongings. It includes threats of violence.
- **Verbal/written** – examples include name-calling or insulting someone about an attribute, quality or personal characteristic.
- **Social** (sometimes called relational or emotional bullying) – examples include deliberately excluding someone, spreading rumours, sharing information that will have a harmful effect on the other person and/or damaging a person’s social reputation or social acceptance.
- **Cyberbullying** – any form of bullying behaviour that occurs online or via a mobile device. It can be verbal or written, and can include threats of violence as well as images, videos and/or audio.

Bullying can be a form of racism, sexism, homophobia, transphobia or other type of social prejudice when the behaviour is targeted at an individual or group because of a personal characteristic, such as race, religion, sex, sexual orientation, gender identity or disability.

**Other distressing and inappropriate behaviours**

Many distressing and inappropriate behaviours may not constitute bullying even though they are unpleasant. Students who are involved in or who witness any distressing and inappropriate behaviours should report their concerns to school staff and our school will follow our Student Wellbeing and Engagement Policy and/or this Bullying Prevention Policy where the behaviour constitutes bullying.

	<p><b>Mutual conflict</b> involves an argument or disagreement between people with no imbalance of power. In incidents of mutual conflict, generally, both parties are upset and usually both want a resolution to the issue. Unresolved mutual conflict can develop into bullying if one of the parties targets the other repeatedly in retaliation.</p> <p><b>Social rejection or dislike</b> is not bullying unless it involves deliberate and repeated attempts to cause distress, exclude or create dislike by others.</p> <p><b>Single-episode</b> acts of nastiness or physical aggression are not the same as bullying. However, single episodes of nastiness or physical aggression are not acceptable behaviours at our school and may have serious consequences for students engaging in this behaviour. Grovedale West Primary School will use its Student Wellbeing and Engagement Policy to guide a response to single episodes of nastiness or physical aggression.</p> <p><b>Harassment</b> is language or actions that are demeaning, offensive or intimidating to a person. It can take many forms, including sexual harassment and disability harassment.</p> <p><b>Discrimination</b> is behaviour that treats someone unfavourably because of a personal characteristic (for example, race, religious belief or activity, disability, sex or intersex status, gender identity or sexual orientation).</p> <p>Discrimination, harassment, and any other inappropriate behaviour is not tolerated at our school and there may be serious consequences for students engaging in this behaviour. This includes any form of racism, religious or disability discrimination, sexism, homophobia, transphobia, or any other behaviour that targets an individual or group. Bullying prevention	<p>Grovedale West Primary School has a number of programs and strategies in place to build a positive and inclusive school culture and relationships to promote wellbeing. We strive to foster a school culture that prevents bullying behaviour by modelling, encouraging and teaching behaviour that demonstrates acceptance, kindness and respect.</p> <p>Bullying prevention at Grovedale West Primary School is proactive and is supported by research that indicates that a whole school, multifaceted approach is the most effect way to prevent and address bullying. At our school:</p> <ul style="list-style-type: none"> <li>• We identify and implement evidence-based programs and initiatives from the <a href="#">Schools Mental Health Menu</a> that are relevant to preventing and addressing bullying and help us to build a positive and inclusive school climate. They include School Wide Positive Behaviors and Respectful Relationships.</li> <li>• Student are supported by Mental Health and Wellbeing Leader and Wellbeing Counsellor.</li> <li>• We strive to build strong partnerships between the school, families and the broader community that means all members work together to ensure the safety of students.</li> <li>• We participate in the Respectful Relationships initiative, which aims to embed a culture of respect and equality across our school.</li> <li>• We celebrate the diverse backgrounds of members of our school community and teach multicultural education, including Aboriginal History, to promote mutual respect and social cohesion.</li> </ul>

	<ul style="list-style-type: none"> <li>• We participate in the Safe Schools program to help us foster a safe environment that is supportive and inclusive of LGBTIQ+ students.</li> <li>• Teachers are encouraged to incorporate classroom management strategies that discourage bullying and promote positive behaviour.</li> <li>• In the classroom, our social and emotional learning curriculum teaches students what constitutes bullying and how to respond to bullying behaviour assertively. This promotes resilience, assertiveness, conflict resolution and problem solving.</li> <li>• We promote upstander behaviour as a way of empowering our students to take appropriate action positively and safely, when they see or hear of a peer being bullied.</li> <li>• We seek to empower students to be confident communicators and to resolve conflict in a non-aggressive and constructive way.</li> <li>• Students are encouraged to look out for each other and to talk to teachers and older peers about any bullying they have experienced or witnessed.</li> <li>• We use the Zones of Regulation to support students to self-regulate.</li> </ul> <p>For further information about our engagement and wellbeing initiatives, please see our Student Wellbeing and Engagement policy</p>
Incident responses	<p><b>Reporting concerns to Grovedale West Primary School</b></p> <p>Bullying is not tolerated at our school. We ensure bullying behaviour is identified and addressed with appropriate and proportionate consequences. All bullying complaints will be taken seriously and responded to sensitively. Students who may be experiencing bullying behaviour, or students who have witnessed bullying behaviour, are encouraged to report their concerns to school staff or another trusted adult as soon as possible. Our ability to effectively reduce and eliminate bullying behaviour is greatly affected by students and/or parents and carers reporting concerning behaviour as soon as possible, so that the responses implemented by Grovedale West Primary School are timely and appropriate in the circumstances. We encourage students to speak to their teacher, however, students are welcome to discuss their concerns with any trusted member of staff including other teachers, wellbeing staff, school social worker etc.</p> <p>Parents or carers who develop concerns that their child is involved in, or has witnessed bullying behaviour at Grovedale West Primary School should contact the Office where their request will be forward to the child’s teacher or a member of the leadership team or Wellbeing Coordinator.</p> <p><b>Investigations</b></p> <p>When notified of alleged bullying behaviour, school staff are required to:</p> <ol style="list-style-type: none"> <li>1. record the details of the allegations including the relevant location, time and details onto a student file.</li> <li>2. inform the relevant Year Level Coordinator, Student Wellbeing Team, Assistant Principal, Principal.</li> </ol> <p>The teacher is responsible for investigating allegations of bullying in a timely and sensitive manner. To appropriately investigate an allegation of bullying, the investigator may:</p>

- speak to the those involved in the allegations, including the target/s, the students allegedly engaging in bullying behaviour/s and any witnesses to the incidents
- speak to the parent/carer(s) of the students involved
- speak to the teachers of the students involved
- take detailed notes of all discussions for future reference
- obtain written statements from all or any of the above.

All communications in the course of investigating an allegation of bullying will be managed sensitively. Investigations will be completed as quickly as possible to allow for the behaviours to be addressed in a timely manner.

The objective of completing a thorough investigation into the circumstances of alleged bullying behaviour is to determine the nature of the conduct and the students involved. A thorough understanding of the alleged bullying will inform staff about how to most effectively implement an appropriate response to that behaviour.

Serious bullying, including serious cyberbullying, is a criminal offence and may be referred to Victoria Police. For more information, see: [Brodie's Law](#).

### **Responses to bullying behaviours**

When a staff member has sufficient information to understand the circumstances of the alleged bullying and the students involved, a number of strategies may be implemented to address the behaviour and support affected students in consultation with the teacher, Assistant Principal, Principal, Department of Education and other relevant support staff.

There are a number of factors that will be considered when determining the most appropriate response to the behaviour. When making a decision about how to respond to bullying behaviour, Grovedale West Primary School will consider:

- the age, maturity and individual circumstances of the students involved
- the severity and frequency of the bullying, and the impact it has had on the target student
- whether the student/s engaging in bullying behaviour have displayed similar behaviour before
- whether the bullying took place in a group or one-to-one context
- whether the students engaging in bullying behaviour demonstrates insight or remorse for their behaviour
- the alleged motive of the behaviour.

Staff may implement all, or some of the following responses to bullying behaviours:

- Offer wellbeing support, including referral to the Student Wellbeing Team, SSS, external provider to:
  - the target student or students
  - the students engaging in the bullying behaviour
  - affected students, including witnesses and/or friends of the target student.
- Facilitate a restorative practice meeting with all or some of the students involved. The objective of restorative practice is to repair relationships that have been damaged by bringing about a sense of remorse and restorative action on the part of the person who has bullied someone and forgiveness by the person who has been bullied.

	<ul style="list-style-type: none"> <li>• Facilitate a mediation between some or all of the students involved to help to encourage students to take responsibility for their behaviour and explore underlying reasons for conflict or grievance. Mediation is only suitable if all students are involved voluntarily and demonstrate a willingness to engage in the mediation process.</li> <li>• Implement a Method of Shared Concern process with all students involved in the bullying using the schools RISE behaviour process.</li> <li>• Facilitate a Student Support Group meeting and/or Behaviour Support Plan for affected students.</li> <li>• Prepare a Safety Plan or Individual Management Plan restricting contact between target and students engaging in bullying behaviour.</li> <li>• Monitor the behaviour of the students involved for an appropriate time and take follow up action if necessary.</li> <li>• Implement cohort, year group, or whole school targeted strategies to reinforce positive behaviours, for example use of the 5 finger Rule and the SWPB Behaviour stepped process.</li> <li>• Implement proportionate disciplinary consequences for the students engaging in bullying behaviour, which may include removal of privileges, detention, suspension and/or expulsion consistent with our Student Wellbeing and Engagement policy, the Ministerial Order on Suspensions and Expulsions and any other relevant Department policy.</li> </ul> <p>Grovedale West Primary School understands the importance of monitoring and following up on the progress of students who have been involved in or affected by bullying behaviour. Where appropriate, school staff will also endeavour to provide parents and carers with updates on the management of bullying incidents. Staff are responsible for maintaining up to date records of the investigation of and responses to bullying behaviour.</p>
